<p>6 <u>EXTRA ALLOWANCE</u> – For Delhi, Bangalore, Jaipur, Kochi, Mumbai, Kolkata and Chennai sightseeing whether Half day or Full Day. In case of Delhi irrespective of reporting at Noida or Gurgaon hotels. In Mumbai irrespective of city or Suburb hotels. It is mandatory for the guide to report at the hotel. However, in case on the request of the guide, if guide reports at any monuments instead of the hotel, then this conveyance charges would not be applicable. This amount be included by the Guide while raising invoice and payable once a day.</p>	<p>500</p>

Note:-		
Programme I – Only evening Aarti:- In this case only half day charges would be payable plus special allowance as above. Language guide would be paid accordingly.		
Programme II – Early morning river tour and then half day Temple / City tour or Sarnath in place of city tour, evening Aarti:- In this case the charges payable would be full day for the morning tour assignment plus the morning river tour allowance and for the evening only half day charges		

without any other Aarti or conveyance allowance. In this case only one full day language allowance would be payable.

Programme III – Early morning River cruise, morning Temple / City tour , afternoon excursion to Sarnath , evening Aarti:- In this case, half day charges for the morning River tour plus the River tour allowance and full day charges for the Temple / City tour and Sarnath would be payable plus only the evening Aarti allowance would be payable. The language allowance for full day will be payable.

Programme IV – Morning Temple tour, Afternoon Sarnath or Vice Versa:- In this case only full day charges would be payable with no other allowance. The language allowance for full day will be payable.


Programme V – Afternoon Sarnath with evening Aarti or Afternoon city tour with evening Aarti:- In this case full day charges would be payable.


Programme VI – Early morning River tour and evening Aarti only:- In this case, one half day charges for the morning tour plus the river tour allowance plus half day charges for evening Aarti would be payable with allowance. Language allowance would be payable as one full day only.

18 The fee and allowance agreed above between IATO and TGFI are to be paid in full and are not negotiable. There will be no extra charges in addition to the above for escorting groups.

19 Note:

- There would be no half days sight -seeing in Delhi and all sight-seeing will be for full day.
- Members are requested to use Ministry of Tourism, Govt. of India recognized IITG guides.
